WHEREAS, the Board of Directors (the "Board") of the California Housing Finance Agency (the "Agency") did, on January 18, 1977, adopt Resolution 77-6, authorizing commitment of funds to Project No. 76-67-S, Reseda East (the "Project"); and

WHEREAS, the Board did also, on November 15, 1977, adopt Resolution 77-78, authorizing an extension in the time of the commitment of funds to the Project; and

WHEREAS, the Project is ready for loan closing and the staff of the Agency have recommended an increase in the loan amount; and

WHEREAS, the Loan Committee of the Board has reviewed the staff recommendations and has recommended that the loan amount be increased.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the California Housing Finance Agency as follows:

1. The loan amount for project 76-67-S, Reseda East, be and is hereby increased to ~~\$2,693,000.~~ *\$2,521,000.00* *SH*
2. The President or the Senior Vice President is hereby authorized and instructed to issue an amendment to the loan commitment letter reflecting the changes authorized herein.
3. This Resolution should take immediate effect.
