

RESOLUTION LC-79- 19

RESOLUTION EXTENDING LOAN COMMITMENTS TO PROJECT

WHEREAS, the Board of Directors (the "Board") of the California Housing Finance Agency (the "Agency") did, on March 20, 1979 adopt Resolution 79-30 authorizing a loan commitment to project 78-24-S, Villa Marisol (formerly Marisol Gardens) (the "Project"); and

WHEREAS, Resolution 79-30 did empower the President to offer a loan commitment, for a period of not to exceed a total of one hundred eighty (180) days from the date of loan commitment execution by both parties; and

WHEREAS, the Project has received a loan commitment which will expire September 15, 1979; and

WHEREAS, the Agency desires to extend the loan commitment of the Project for a period not to exceed ninety (90) days from the date of expiration indicated above.

NOW, THEREFORE, BE IT RESOLVED, as follows:

1. The President, or in his absence, the Senior Vice President-Programs, is hereby authorized to extend the loan commitment for the above named project for a period not to exceed ninety (90) days from the expiration of the current commitment, not to extend beyond December 14, 1979.
2. Said extension(s) may be made in successive thirty (30) day increments, only upon the judgement of the President, or Senior Vice President-Programs, that an extension is warranted, necessary, and, in the best interests of the Agency.
3. This Resolution shall take effect immediately.
