How to Observe and Offer Public Comments at remote CalHFA Board of Directors Meetings

- By addressing the Board, you agree to be recorded and broadcast on video.

How To View The Meeting via Zoom REGISTER for the meeting by clicking on the link as shown on the meeting Agenda or Notice. CHOOSE Register with your Zoom Account or Register with your email and enter the verification code sent to the email address you provided JOIN the meeting when it starts by clicking on the link in the confirmation email you received after registering.
