BOARD OF DIRECTORS 1 OF THE CALIFORNIA HOUSING FINANCE AGENCY 2 3 4 **RESOLUTION NO. 23-12** 5 6 RESOLUTION AUTHORIZING USE OF FUNDS IN THE DREAM FOR ALL FUND 7 8 WHEREAS, on June 30, 2022, Senate Bill No. 197 came into effect and, among other 9 things added a new Chapter 12 (commencing with Section 51520) to Part 3 of Division 31 of the 10 Health and Safety Code, which created the California Dream for All Program (the "Program") 11 and also established the California Dream for All Fund (the "Fund"), 12 13 14 WHEREAS, Assembly Bill No. 178 amended the Budget Act of 2022 and appropriated \$500,000,000 to the Fund to be used by the California Housing Finance Agency ("Agency") to 15 establish and implement the Program, 16 17 WHEREAS, the CalHFA Board of Directors ("Board") previously authorized the use of 18 the Fund pursuant to Resolution 22-21 for the creation and implementation of the Program, 19 20 WHEREAS, the Dream for All Program launched on March 27, 2023 and deployed \$300 21 million for the first phase of the Program. 22 23 WHEREAS, Senate Bill No. 104 amended the Budget Act of 2023 and appropriated an 24 additional \$20,000,000 to the Fund to be used by the Agency to continue implementation of the 25 Program in a phase two ("Phase Two"), bringing remaining appropriation authority available for 26 the second phase of the Program to \$220 million in addition to any amounts returned to the Fund 27 through repayments or cancelled applications from the first phase of the program. 28 29 WHEREAS, Health and Safety Code Section 51004 provides that the Agency may utilize 30 moneys which may be appropriated from time to time by the Legislature for effectuating its 31 purposes; and, 32 33 WHEREAS, Agency staff has determined that it is in the public interest for the Agency 34 to accept and use the funds allocated pursuant to the Budget Act of 2023, as amended by Senate 35 Bill No. 104, for the purposes stated therein, and to formally implement Phase Two of the 36 Program. 37 38 NOW, THEREFORE, BE IT RESOLVED by the Board, in consideration of the above, 39 as follows: 40 41 Section 1. Recitals. The board hereby accepts that the above recitals are accurate and 42 have served, together with the Staff Report accompanying this Resolution and the additional 43 information the Board has been provided at the meeting, as the basis for the approvals and 44 directives set forth in this Resolution. 45 46

<u>Section 2. Use of Funds.</u> The Agency hereby acknowledges receipt of the funds allocated pursuant to the Budget Act of 2023, as amended by Senate Bill No. 104, and authorizes that such funds be used in accordance with the purposes stated therein, pursuant to Chapter 12 of Part 3 of Division 31 of the Health and Safety Code.

6 <u>Section 3. Authorization of Phase Two of the Program</u>. The Board hereby approves of 7 implementing Phase Two of the Program, as more particularly described in the Staff Report, and 8 authorizes the Executive Director or her designee to implement said program by disbursing the 9 Fund as soon as practicable, and to execute all agreements, amendments and ancillary documents, 10 and to make any changes to said program reasonably necessary, to effectuate the intent for which 11 the Fund has been allocated to the Agency.
