## How To View The Meeting via Zoom

**REGISTER** for the meeting by clicking on the link as shown on the meeting Agenda or Notice.

**CHOOSE** Register with your Zoom Account *or*

Register with your email and enter the verification code sent to the email address you provided

**JOIN** the meeting when it starts by clicking on the link in the confirmation email you received after registering.

During the public comment portion of the meeting, indicate you would like to ask a question or address the Board by clicking on the “raised hand” icon. This will alert the meeting organizer that you have a question. Your comment will be part of the official public record.

- Your first and last name (not required, you may still submit without identifying yourself).
