Updated Mortgage Credit Certificate Tax Credit Program (MCC) Income Limits

This bulletin supersedes the MCC income limits provided in Program Bulletin #2013-12, dated December 2, 2013. These limits apply to all Mortgage Credit Certificate Tax Credit Program applications per the attached income limit tables. Depending on the family size, there may be differences in the income limits shown on the schedules. When qualifying a borrower for a CalHFA mortgage loan with one or more loans, the more restrictive limits must be applied.

The MCC income limits have been increased. The income limits are effective for new reservations received on or after January 6, 2014.

The attachment shows the maximum income limits by household size for non-targeted and targeted areas for use with the Mortgage Credit Certificate Tax Credit Program.
