## MINUTES

### California Housing Finance Agency (CalHFA) Board of Directors Meeting May 20, 2021

Meeting noticed on May 10, 2021

#### 1. ROLL CALL

The California Housing Finance Agency Board of Directors Meeting was called to order at **10:03 a.m.** by Board member Preston Prince. A quorum of members was present. Mr. Prince was acting in place of Acting Chair Gunning. Mr. Gunning arrived at approximately 10:45 a.m. and took over the Chair role.

#### 2. Approval of the Minutes – March 25, 2021

The minutes were approved by unanimous consent of all members in attendance.

#### 3. Chairperson/Executive Director comments

Chairperson comments:

- Mr. Prince welcomed everyone to the meeting.

Executive Director comments:

- Acting Executive Director Cavier told the Board about Governor Newsom's \$100B California Comeback Plan that includes the goals of helping keep Californians in their homes and remaining focused on production of affordable housing statewide. The Governor's proposed budget includes allocating federal funds to CalHFA for augmentation of its First-time Homebuyer Assistance programs and for expansion of its Accessory Dwelling Unit program.
- While first-quarter data is still being audited by CalHFA, Cavier was able to share that the National Mortgage Settlement Housing Counseling Program has provided counseling sessions to about 5,000 families.

#### **4. Executive Director recruitment process update**

LeBoeuf updated the Board that the Governor's Office has several solid candidates for the Executive Director position. While the Governor's Office continues to interview candidates, LeBoeuf expected their final set of recommendations in the coming weeks.
