## UPDATED INCOME LIMITS

CHFA has received the new 2002 federal income limits for Homeownership Programs. This bulletin supersedes the income limits provided in Program Bulletin #2001-27, dated November 1, 2001. These new limits may be utilized for all new single loan (SL) reservations and for any new loans reserved against outstanding Forward Commitments effective March 2, 2002.

**Please note that all counties, except Los Angeles County, reflect an increase over the 2001 limits. The limits for Los Angeles County are set at the statewide median, which is higher than the county median, but lower than the current limit, which reflects the 2001 High Housing Cost Area (HHCA) adjustments. Upon receipt of the 2002 HHCA data, CHFA will re-publish the income limits based on the new calculations, if changes are applicable.**

Attachment A shows the new applicable CHFA low- and moderate-income limits for both new construction and existing resale housing in the non-targeted areas of each county. These limits are used to determine eligibility for CHFA's Homeownership Program first mortgages and the 100% Loan Program (CHAP) second mortgages.

Attachment B shows the applicable income limits for CHFA first and second mortgages in Federally-designated Targeted Areas (See Exhibit D in the Program Manual). The Targeted Area limits are for moderate-income borrowers only. These limits are also used for calculating the Federal recapture provision and by Loan Servicers for assumptions of CHFA loans.

Attachment C shows the HCD moderate-income limits by family size for each county. This schedule is used to determine eligibility for the California Homebuyers Downpayment Assistance Program (CHDAP) junior lien program. The program is currently available only to nonprofit corporations organized under IRS section 501 (c) (3) who are developing mutual self-help housing utilizing the Agency's Self-Help Builder Assistance Program (SHBAP).
